4. First-aid measures

Most important symptoms/effects, acute and delayed

Symptoms: Product may hydrolyse upon contact with body fluids in the gastrointestinal tract to produce additional methanol; therefore, consider the signs/symptoms of methanol poisoning and also observe the known latency period of several days!

5. Fire-fighting measures

Specific hazards arising from the chemical: Reacts with water liberating small amounts of methanol. Vapors are flammable and heavier than air. Vapors may travel across the ground and reach remote ignition sources causing a flashback fire danger. In case of fire, carbon monoxide and carbon dioxide may be formed. Acute overexposure to the products of combustion may result in irritation of the respiratory tract. Measurements at temperatures above 150°C in presence of air (oxygen) have shown that small amounts of formaldehyde are formed due to oxidative degradation.

Special protective equipment and precautions for firefighters

Special fire fighting procedures: Move container from fire area if it can be done without risk. Use water spray to keep fire-exposed containers cool.

Special protective equipment for fire-fighters: Firefighters must wear NIOSH/MSHA approved positive pressure self-contained breathing apparatus with full face mask and full protective clothing.

6. Accidental release measures

Methods and material for containment and cleaning up: Wipe, scrape or soak up in an inert material and put in a container for disposal. Wash walking surfaces with detergent and water to reduce slipping hazard. Wear proper protective equipment as specified in the protective equipment section.
